About us

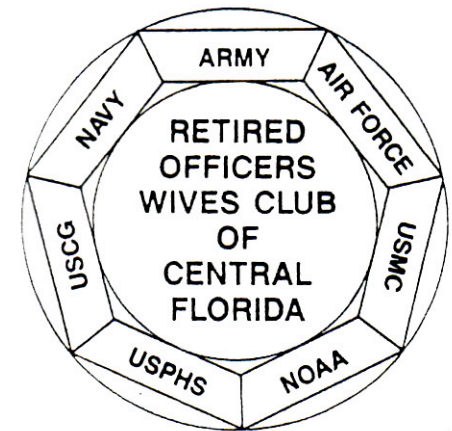
